3. ORS 192.660(2)(d) Labor Negotiator Consultations

To conduct deliberations with persons designated by the governing body to carry on labor negotiations.

4. ORS 192.660(2)(e) Real Property Transactions

To conduct deliberations with persons designated by the governing body to negotiate real property transactions.

5. ORS 192.660(2)(f) Exempt Public Records

To consider information or records that are exempt by law from public inspection.

6. ORS 192.660(2)(g) Trade Negotiations

To consider preliminary negotiations involving matters of trade or commerce in which the governing body is in competition with governing bodies in other states or nations.

7. ORS 192.660(2)(h) Legal Counsel/Litigation

To consult with counsel concerning the legal rights and duties of a public body with regard to current litigation or litigation likely to be filed.

8. ORS 192.660(2)(i) Performance Evaluations of Public Officer and Employees

To review and evaluate the employment-related performance of the chief executive officer of any public body, a public officer, employee or staff member who does not request an open hearing.
